Original Datasets

Victims of Double Extortion Ransomware Attacks Dataset

- Includes 4,194 victims of double-extortion ransomware attacks by 55 ransomware groups posted to the dark web between May 2019 and May 2022
- All victims are classified according to country (physical location or headquarters) and sector (according to a 14-sector scheme)
- Includes the identity of the threat actor and the approximate date of each attack

Cross-National Cryptocurrency Trades Dataset

- Includes 150 million transactions from 65 of the world's highest volume cryptocurrency exchanges between 07/01/2020 and 08/15/2020
- Details the time, amount, and price of trades between Bitcoin and Ethereum to dollars,

euros, and other international currencies

- Collected in real time from each site's API using remote servers from Amazon Web Services

International Money Laundering Cases Dataset

- Details money laundering cases against individuals and banks between 01/01/2001 and 07/01/2020
- Collected using keyword searches of articles in the *New York Times* and *The Financial Times*
- Presents the first dataset of money laundering cases and is supported by the Browne Center for International Politics and the University of Pennsylvania's GAPSA Provost Innovation Fellowship
